#### 26 Abstract

27 Visuospatial memory (VSM) performance depends on intrinsic (biopsychosocial parameters) 28 and extrinsic (space) factors. We aimed at characterizing the determinants of VSM 29 performance according to space. Young healthy adults, 20 males and 41 females  $(23 \pm 3 \text{ years})$ old), were assessed for VSM performance through a pathway learning task, in reaching 30 31 (eCorsi Block Tapping task) and walking space (Virtual Walking Corsi Task). We evaluated psychosocial factors through seven questionnaires – Epworth Sleepiness Scale, Pittsburgh 32 Sleep Quality Index, Fatigue Severity Scale, Profile of the Mood States, 2<sup>nd</sup> edition, short 33 34 version, Coping Inventory for Stressful Situations, Measurement of Ambiguity Tolerance, 35 Motives for Physical Activities Measure-Revised, mental rotation capabilities and locomotor 36 characteristics (physical activity level through embedded trackers and the International 37 Physical Activity Questionnaire, and gait parameters). The most explanatory biopsychosocial 38 determinants of VSM performance were i) mental rotation capabilities and fatigue indicator 39 in reaching space, and ii) mental rotation capabilities and physical activity level (tracked 40 active energy expenditure only) in walking space. These results suggest that specific 41 parameters should be preferred for the evaluation and strengthening of VSM capabilities in 42 both reaching or walking spaces.

65 **1. Introduction**

72 VSM performance is influenced by the space where the experiment takes place (Coluccia & 73 Louse, 2004; Piccardi et al., 2014). The effect of space during a pathway learning task is well 74 known, with better performance found in walking than in reaching space (Piccardi et al., 75 2014). Many determinants of VSM performance are influenced by space, such as sex 76 (Piccardi et al., 2014; Piccardi et al., 2008), age (Perrochon et al., 2018), memory (Lupo et al., 2018), encoding (Livingstone-Lee et al., 2014; Lupo et al., 2018; Piccardi et al., 2016), 77 and exploration strategies (Livingstone-Lee et al., 2014). Overall, men perform better than 78 79 women, younger better than older people, and people who spontaneously use an allocentric 80 navigation strategy outperform the egocentric ones. Thus, reaching and walking spaces involve different cognitive (Piccardi et al., 2014) and motor (Röser et al., 2016) processes. 81 82 Indeed, the navigation involved in walking space requires walking, mental rotation and 83 reorientation.

In parallel, other factors seems to modify VSM performance, such as biopsychosocial parameters. On the cognitive aspect, we can mention psychosocial factors such as sleep (Nakagawa et al., 2016) or motivation (Pazzaglia et al., 2018) (i.e., spatial self-efficacy and pleasure in exploring) that increase VSM performance, and anxiety and/or stress (Pazzaglia et al., 2018; Wolbers & Hegarty, 2010) and fatigue that decrease it (Siengsukon et al., 2018).

90 Many other intrinsic parameters, such as recently described personality traits (Carbone et al., 91 2019) have an impact on VSM. One can also mention mental rotation capabilities, which 92 influence environment learning (Pazzaglia & Meneghetti, 2012), as well as navigation and 93 way-finding capacities (Hegarty et al., 2006; Labate et al., 2014).. With regard to the 94 locomotor aspect, physical activity (PA) is positively correlated with VSM performance 95 (Merom et al., 2016). An increase in PA level led to a greater VSM performance in younger (Stroth et al., 2009) and in older adults (Erickson et al., 2011; Merom et al., 2016; Wang et 96 97 al., 2014). Furthermore, environmental factors, such as the type or level of PA practiced, 98 might be a source of difference in VSM performance, especially sports activities stimulating 99 the development of spatial capabilities (Coluccia & Louse, 2004; Merom et al., 2016; 100 Wolbers & Hegarty, 2010).

Previous studies showed that VSM performance is influenced by many different parameters, 102 but it remains to be determined which of these determinants contribute the most to 103 104 performance, and whether these determinants differ according to space. We therefore 105 investigated whether, and to what extent, VSM performance in different spaces could be 106 associated with either cognitive (mental rotation capabilities and psychosocial parameters) 107 and/or locomotor aspects (PA level, gait parameters). We hypothesised that different 108 biopsychosocial parameters affecting VSM performance might be influenced by space (i.e., 109 mental rotation, psychosocial factors, PA level or gait parameters).

111 **2. Methods** 

112

113 2.1. Participants

115 63 young healthy subjects volunteered for this cross-sectional study, and 61 were analysed 116 (20 males, 41 females;  $23 \pm 3$  years old) (Figure 1). The inclusion criteria were age over 18 117 years and fluent in French. The non-inclusion criteria were any diagnosis of disorders that 118 could affect memory, perception or walking (physical, visual, perceptual, cognitive, 119 neurological or psychiatric disorders). The exclusion criteria were to wear the PA tracker less 120 than 75% of the time over 7 days. Informed consent was obtained from all participants in 121 accordance with the guidelines of the local ethics committee.

#### 2.2. Experimental design and outcomes

124

The assessment of subjects' VSM performance, locomotor (PA level, gait parameters) and cognitive aspects (psychosocial parameters and mental rotation capabilities) required four appointments scheduled within 10 consecutive days (Figure 1). Two distinct examiners made evaluations; one was responsible for VSM performance, while the other oversaw biopsychosocial assessments.

We evaluated subjects' VSM performance through a pathway learning task. We used the 133 Corsi Block-tapping Test in reaching space (e-Corsi Block Task (ECBT)) and in walking 134 135 space (Virtual Walking Corsi Task (VWCT)) according to methods described in literature 136 (Perrochon et al., 2018). The VWCT was performed on the "Virtual Carpet", composed of the association between a projected scene and movement tracking (Perrochon et al., 2018). 137 138 The subject had to memorize (encoding phase) and then repeat (recall phase) a sequence of elements, pointing on the screen during ECBT and navigating on the projected scene during 139 140 VWCT. The validation of a sequence was given by the examiner and led to an increase in the 141 number of illuminated elements composing the sequence (from 2 to 9). In case the subject 142 missed twice, the test was stopped and we considered the number of elements of the last 143 sequence repeated correctly as the span score (Berch et al., 1998). VSM performance was 144 given by the span score that the subjects achieved in reaching both (ECBT) and walking 145 (VWCT) space.

2.1.1. Locomotor aspects

148

We evaluated subjects' PA level according to self-reports and tracker records. We used a 149 150 validated questionnaire, the International Physical Activity Questionnaire (IPAQ) (Craig et 151 al., 2003), estimating the time spent resting or in activity during these last 7 days. The 152 continuous record consisted in wearing a PA tracker, the Armband ® (Bodymedia, 153 Pittsburgh, USA) on the left triceps muscle for 7 days. This embedded tool, which is 154 automatically activated in contact with skin, has been validated in the ongoing daily evaluation of steps and energy expenditure (Alharbi et al., 2017). We analysed the active 155 156 energy expenditure (AEE) and the step number (SN) as a daily average calculated over 7

days. This information was provided by the Armband ® data gathering (*software* SenseWear
Professional ® 7.0).

We analysed subjects' gait over 20 meters with motion sensors MTi-1® (XSens, Enschede, Netherlands), which informed us about subjects' gait speed (m.s<sup>-1</sup>) and gait cycle time variability(ies). Each subject had to walk over 10 meters back and forth with a half-turn around a post halfway, at a spontaneous speed, wearing two sensors on the feet, one on the back, and one on the forehead.

166 2.2.1. Cognitive aspects

167

168 To assess subjects' psychosocial factors, we used seven questionnaires focusing on i) sleep (Epworth Sleepiness Scale (ESS) (Johns, 1991), Pittsburgh Sleep Quality Index (PSQI) 169 170 (Buysse et al., 1989)), ii) fatigue (Fatigue Severity Scale (FSS) (Krupp et al., 1989), Profile of the Mood States, 2<sup>nd</sup> edition, short version (POMS-2) (Heuchert & McNair, 2012)), iii) 171 172 stress (Coping Inventory for Stressful Situations (CISS) (Endler & Parker, 1990)), iv) flexibility as personality trait (Measurement of Ambiguity Tolerance (MAT-50) (Norton, 173 174 1975)), and v) motivation (Motives for Physical Activities Measure-Revised (MPAM-R) 175 (Ryan et al., 1997)). All these questionnaires were provided by the examiner and completed by the subject through the SphinxOnline® platform in the presence of the examiner, who 176 177 answered questions.

179 To evaluate the subjects' mental rotation capabilities, we used the Mental Rotation Test 180 (MRT) (Peters et al., 1995). The MRT is a paper and pencil test consisting of 24 items, in 181 which the candidate must recognize, among 4 forms, the one corresponding to the presented182 model.

184 2.2. Statistical analysis

185

186 Univariable linear regressions were performed to examine relationships between PA level, psychosocial factors, gait parameters or mental rotation capabilities (independent variables) 187 188 and span scores in ECBT and VWCT (dependent variables) to determine which of these 189 should be integrated in the subsequent multivariable regression models. Separate 190 multivariable linear regressions were run to examine whether biopsychosocial variables 191 would predict VSM performances in different spaces. We controlled the multicollinearity by 192 deleting the predictors whose variance inflation factors value < 5. The statistical analysis was 193 performed using IBM SPSS ® Statistics version 22 (IBM Corp, Armonk, USA), and result 194 significance was set with p < 0.05.

196 **3. Results** 

197

*3.1. Participant data* 

199

Participant characteristics; VSM performance, PA level (self-reported and tracked), gait
parameters, psychosocial factors, and mental rotation capabilities are summarized in Table 1.

- 217 *3.2. Univariable linear regression*
- 218

Significant correlations between VSM performance and biopsychosocial parameters are shown in Table 1. Gender was associated with VWCT (r = 0.43, p < 0.001), but not with ECBT. As expected, there was a significant correlation between ECBT and VWCT span scores (r = 0.46, p < 0.01).

223

In reaching space (i.e., ECBT), VSM performance was correlated with AEE (r = 0.38, p < 0.001), gait speed (r = 0.29, p < 0.05), fatigue factor PSQI (r = -0.27, p < 0.05), indicator FSS (r = -0.44, p < 0.001), and MRT (r = 0.26, p < 0.05). ECBT was most strongly correlated with FSS.

In walking space (i.e., VWCT), VSM performance was significantly correlated with AEE (r = 0.49, p < 0.001), SN (r = 0.34, p < 0.001), fatigue factor PSQI (r = -0.32, p < 0.05) and indicators FSS (r = -0.40, p < 0.001), POMS-2 fatigue (r = -0.37, p < 0.001), and MRT (r = 0.37, p < 0.001). VWCT was most strongly correlated with AEE, FSS, POMS-2 fatigue and MRT.

All other psychosocial variables were not associated with VSM performance in two spaces.

237

In the multivariate linear regressions, we integrated gender in the model as a control variable, and the main significant variables significant in both spaces from the univariate linear regression to predict VSM performance in the ECBT and VWCT.

Results in Table 2.a show that only MRT and FSS were significantly associated with ECBT (p < 0.05). Other biopsychosocial variables were not related with ECBT. We performed a

243 similar hierarchical linear regression for walking space, and we determined that AEE and

244 MRT remained significant predictors of VWCT (p < 0.05), as can be seen in Table 2.b. Other

245 biopsychosocial variables were not associated with VWCT.

262	We found that PA level and mental rotation significantly predicted VSM performance in
263	walking space, whereas fatigue and mental rotation predicted VSM performance in reaching
264	space. Interestingly, the total variance accounted for was 28.5% in reaching space (i.e., e-
265	CBT), whereas it was above 40.6% in walking space (i.e., VWCT) (Tables 2.a and 2.b).

267	4. Discussion
268	
269	In this study, we investigated the determinants of VSM performance during a pathway
270	learning task in different spaces. The most explanatory biopsychosocial determinants of VSM
271	performance were mental rotation capabilities and fatigue indicator (i.e., MRT and FSS) in
272	reaching space, and mental rotation capabilities and PA level (i.e., MRT and AEE) in walking
273	space.

mental rotation capabilities are known to play a role in environment learning (Pazzaglia &
Meneghetti, 2012), and way-finding capacities (Hegarty et al., 2006; Labate et al., 2014) in
reaching space. Mental rotation capabilities are also known to play a role during acquisition
and navigation in walking space (Labate et al., 2014): beyond motor and posture control,
mental rotation is an important cognitive task needed for spatial updating during a Corsi
Block-tapping Test in navigation (i.e., VWCT) (Röser et al., 2016).

### 4.1.2. Fatigue in reaching space, PA level in walking space

295

296 We found that PA level (i.e., AEE) was associated with VSM performance in navigation 297 (VWCT). This relationship is usually demonstrated in reaching space (Erickson et al., 2011; 298 Merom et al., 2016; Wang et al., 2014), but was unexplored in walking space. We did not find 299 this result because we studied more explanatory determinants of VSM performance in 300 reaching space (i.e., fatigue that statistically exceeds the PA level in the multivariable model). 301 Furthermore, we observed that this relationship between VSM performance and PA level 302 appears for the tracked PA level only, and never for the self-reported PA level. This 303 difference can be explained by the varying level of reliability of these two instruments. The 304 self-reported perceived PA level is often overestimated (Dyrstad et al., 2014), whereas the 305 AEE parameter was obtained by a validated activity tracker (Alharbi et al., 2017). PA level, 306 measured by PA tracker, seemed to represent a determining parameter of VSM performance 307 in walking space. We believe that walking represents an important part of the PA tracked in 308 our subjects, inducing navigation and soliciting spatial cognition (spatial updating, 309 reorientation, mental rotations). The underlying mechanism seems to be that the individual 310 fitness level has an impact on brain region activation associated with spatial learning 311 (Holzschneider et al., 2012). More generally, PA encourages brain plasticity, increasing cerebral blood flow and oxygenation (Cameron et al., 2015), as well as the size of the anterior
hippocampus, leading to improvements in spatial memory (Erickson et al., 2011). PA could
even be an epigenetic modulator of brain plasticity and cognition, influencing long-term brain
function and behaviour (Fernandes et al., 2017).

317 On the other hand, we found that VSM performance in reaching space was negatively 318 associated with the fatigue indicator (i.e., FSS), assessing the effect of fatigue on different 319 activities. Previous studies have demonstrated the relationship between sleep (Nakagawa et 320 al., 2016) or fatigue (Siengsukon et al., 2018) and VSM performance in reaching space. This 321 is the first study which demonstrates a relationship between fatigue and pathway learning in 322 reaching space. An increase in subjects' fatigue level during continuous performance of 323 cognitive tasks has already been shown (Sengupta et al. 2017). In our study, ECBT and 324 VWCT are particularly long and uninterrupted cognitive tasks that seem to be sensitive to 325 fatigue. Indeed, the ECBT and VWCT tests required encoding and restoring spans ranging 326 from 2 to 9 elements. During the encoding phase, the sequence was presented with a 1.5 327 second illumination and 1 second extinction frequency. During the restitution phase, the 328 subject was asked to respect an equivalent frequency. In addition, the average performance 329 score is greater than 6, and each span level could be achieved once, or twice in the event of 330 failure. Thus, each participant performed a continuous cognitive task for approximately 20 331 minutes. Nevertheless, fatigue was not resistant in the multivariable linear regression model in 332 walking space, because of more explanatory determinants of VSM performance (i.e., MRT level). 333

335 4.2. The least explanatory biopsychosocial parameters of VSM performance

Beyond the most explanatory biopsychosocial parameters of the VSM performance 337 338 previously discussed, it is worth noting that we evaluated a certain number of parameters that 339 do not emerge from the univariate or multivariate statistical analysis. Thus, in this study, age, body mass index, self-reported PA level (IPAQ), sleepiness (ESS), flexibility (MAT-50), 340 341 stress (CISS), and motivation (MPAM-R) were not associated with VSM performance in 342 reaching or walking space. It is worth noting that our results are probably not due to chance 343 nor to the amount of variables introduced in the model, because the most explanatory 344 biopsychosocial parameters of the VSM performance we found are in line with the literature 345 (mental rotation, physical activity level) and vice-versa for those not correlated (body mass index, gait parameters). Furthermore, we are only discussing the most explanatory 346 347 biopsychosocial parameters of VSM performance, and other parameters participate to a lesser 348 extent, but do not appear in the multivariate model. For example, gender was correlated with VSM performance but became nonsignificant after controlling other valuables in multivariate 349 350 regressions. This may be because these parameters are usually studied independently, and not 351 grouped together. In addition, some parameters are cofactors, such as gender and mental 352 rotation capabilities, in which men outperform women (Coluccia & Louse, 2004). 353 Nevertheless, we can argue that the nature of the task may be the reason why gait was not 354 associated with VSM performance: the spontaneous gait used during the walking test was not 355 the one used during VWCT, which contained an additional cognitive task, the need to reorient 356 oneself, and no time constraint. Regarding motivation, anxiety and depression, they were not 357 resistant in the multivariable linear regression models, while they are described as associated 358 with VSM performance (Pazzaglia et al., 2018; Wolbers & Hegarty, 2010). This may be 359 because we did not use the same scales nor assessed the same parameter dimensions. These 360 authors investigated motivation and anxiety related to navigation (including anxiety and

361 pleasure in exploring), while we measured motivation for physical activity and general362 stressful situations.

### 4.3. Methodological considerations

365

366 VSM and navigation performance are influenced by encoding strategies or reorientation (Coluccia & Louse, 2004; Wolbers & Hegarty, 2010). We could also mention the gender 367 368 effect, navigation strategies, as well as certain hormone levels known to influence orientation 369 and navigation performance (Brake & Lacasse, 2018; Scheuringer & Pletzer, 2017). Further research might benefit from including all these known factors to refine the results, in 370 371 particular regarding the total variance, and therefore the explanatory part of the different 372 determinants studied. In addition, it would be interesting to measure brain activity to better 373 understand the areas involved in each space.

#### 375 Conclusion

376

In both spaces, VSM performance during a pathway learning task was associated with mental rotation capabilities. Among various psychosocial factors, VSM performance was associated with a fatigue indicator in reaching space, and with active energy expenditure, not selfreported PA level, in walking space. Taken together, these results suggest that specific parameters should be preferred for the evaluation and strengthening of VSM capabilities in subjects to increase their navigation capabilities; i.e., their mental rotation capabilities, and their actual level of PA.
